As these subscriptions are received they should be forwarded to the Treasurer, who will notify the subscriber when the bonds subscribed for are ready for delivery. The Treasurer should not make delivery of a bond until he is in receipt of the amount of the subscription which should be the par face value of the bond.

The Treasurer, of course, will see to it, if he accepts checks, that he has the checks of parties whom he deems responsible.

The bonds will be signed by the Treasurer who will sign his name "Chauncey Garlow" over the word "Treasurer"; and signed by the Secretary, who will sign the name "David S. Hill" over the word "Secretary;" and by the Speaker who will sign his name "Deskaheh" over the word "Speaker"; and the seal will at the same time be impressed upon the bond.

It will probably be better for the subscriber to hand to the Committee which takes his subscription the funds to cover the subscription whenever that is convenient, in order to save time and trouble in the issue of the bonds.

It is suggested that only sufficient bonds be signed and sealed at one time to cover the probable immediate demand for them. The unsigned bonds should be carefully placed where there will be no danger that they will be lost or reach improper hands.

The Treasurer should keep a record in a convenient book of the subscriber who takes a bond and the serial number of that bond, and of the amount received on account of it.
